

Barossa Fine Foods 100 Year Giveaway Competition - Terms & Conditions

1. The Promoter is Barossa Fine Foods of registered office address: 7 Ridgeway Road, Edinburgh North, South Australia 5113. The above mentioned company will hereafter be referred to as the 'Promoter.'
2. Employees of the Promoter, their family members, or anyone else connected in any way with the competition or helping to set up the competition, shall not be permitted to enter the competition.
3. To enter the competition, an entrant must:
 - a) Be a current Fine Foodies Member
 - i) As an existing member, or
 - ii) By signing up in store as a new member and completing your registration by visiting <https://barossafinefoods.ezirewards.net/join>
 - b) Visit a Barossa Fine Foods retail store and make any purchase (no minimum spend)
 - c) Scan their Fine Foodies membership card when completing their purchase at a Barossa Fine Foods retail store
4. The starting date of the competition shall be 12:00am Monday 12th August 2024 (ACST). The closing date for entry will be end-of-business (ACST) Saturday 31st August 2024. After this date and time, no further entries to the competition will be permitted.
5. It is the sole responsibility of the prize winner to accept and collect the prize. No responsibility can be accepted by The Promoter for entries not received for any reason.

 - a) For each purchase made by the entrant at a Barossa Fine Foods store, the entrant will receive 1 entry into the weekly draw.
